

Dear Friends and Colleagues,

The local organising committee of the Memory Studies Association 7th Annual Conference is delighted to welcome you to Newcastle-upon-Tyne as we continue our collective conversation as scholars, artists and activists in the vibrant field of memory studies. The title we have chosen for this year's conference is "Communities and Change", a theme that reflects and draws inspiration from Newcastle's specific post-industrial material and social land-scape.

Newcastle-upon-Tyne is a city in the North East of England, a region with a long industrial history linked to shipbuilding and coal mining. The North East has a strong record of local activism and heritage driven by regional change and deindustrialisation. At the same time, the city's roots go deeper and spread wider, with its location on Hadrian's Wall – the northern-most frontier of the Roman Empire. It sits within impressive rural and coastal landscapes, in a rich cultural environment with heritage sites, castles, iconic bridges, museums, and a thriving artistic community. Newcastle is a city committed to social justice, from the Jarrow marchers of 1936, who took the concerns of the unemployed to parliament, to its status as a City of Sanctuary welcoming refugees. The vibrant city continues to be shaped by the changing communities that have made Newcastle their home and through an ongoing engagement with memory and reinvention.

We hope that that theme of "Communities and Change" also reflects the dynamism and diversity of Memory Studies as an expanding field. They are topics that both address loss and trauma but also new dynamic opportunities, calling for different ways of thinking about the past as well as the future. Within communities and through the generations, memories are constantly being shaped and reshaped. Recent decades have also seen waves of crisis and rising populism, and the forced movement of people as a result of ongoing and emerging conflicts. We live in a time where local and global communities and memories are shifting rapidly and being dramatically reconfigured.

The 2023 Newcastle Conference therefore highlights approaches to heritage, the post-industrial, public memory, migration, social justice and human rights, offering a series of related keynote addresses, plenary sessions, roundtables and artistic interventions, exploring connections between local, national and transnational memories. It will also foster discussions around the coloniality of memory and the ongoing work of decolonisation, as well as interrogating the ways in which institutional communities and practice are changing.

Every effort has been made to host the first in-person conference since the Covid-19 pandemic in a way that is rooted in place. We are, therefore, also delighted to offer a wide-ranging <u>Cultural Program</u> of events. The cultural program is running alongside the academic program. It cooperates closely with local memory activists, cultural partners and heritage sites and aims to embed the conference within the host city.

The program of academic activities will take place at the Newcastle Helix. In the following pages, we've put together some practical information about the venue, including onsite WiFi access. You will also find some deals for guests in local restaurants prepared by the NewcastleGateshead Initiative. Our Newcastle University student interns will be available, alongside the local organisers, throughout the conference to answer any queries you might have and to point you in the right direction. We very much hope that you enjoy your stay in Newcastle and will make the most of what this vibrant city has to offer!



Code of Conduct

The Memory Studies Association is a professional association of scholars and practitioners that exists to advance scholarly exchange in the broad field of memory studies. As such, its members agree to abide by the highest standards of professional conduct and civil discourse in all interactions, whether at official meetings, Association-sponsored events, or in professional relationships (e.g. mentoring or internships) that emerge from it. The MSA stands against harassment and disparagement of any kind, and its members are cognizant of the effects differentials in power and prestige can have in professional relationships. Furthermore, the Association welcomes members and participants of every national and ethnic origin, race, creed, color, citizenship, gender identity and sexual orientation. The goal of the MSA is to provide a collegial space where people from different parts of the world are equally represented and respected. As scholars, artists, activists, and professionals, we are mindful of disparities of power, wealth, and security and are committed to exchanging ideas in a civil manner.

The Annual Memory Studies Association Conference is a time when MSA members meet to foster their professional development and scholarly and educational connections in a spirit of discovery and free expression. Conference participants are expected to act in accordance with professional norms and ethics. Speakers are asked to be aware of how language or images may be perceived by others.

Chairs of panels are responsible for helping to create an environment of respect, free from discrimination and harassment, and to respond to incidents of hostile behavior, including intimidation based on age, race, gender identity, ability, ethnicity, country of origin, social class, professional status, religion, or political beliefs. Attendees at the Annual Conference must abide by the MSA Code of Conduct in all conference venues, including at official and unofficial MSA events.

Sustainability Statement

Newcastle University is delighted to be hosting the first in-person MSA Annual Conference since the start of the pandemic. However, we do this in full recognition of the risks that this poses in terms of negative environmental impact and the need for sustainable organisational practice. The conference has been organised with careful consideration of both environmental and financial sustainability. This includes thorough consideration of the sourcing and disposal of all conference materials, the reduction of the conference's carbon footprint, and sustainable approaches to catering and refreshments.

Our steps towards sustainability:

- We are not providing printed programs to reduce paper waste. Instead, we have introduced easily accessible digital formats for the program, acknowledging that digital formats also have an environmental impact.
- We commit to recycling all paper waste from the conference where possible.
- Conference accessories have been ethically and sustainably sourced. Our lanyards are made of recycled materials and our ecological tote bags are made from recycled cotton t-shirt material (60%) and recycled polyster from plastic bottles (40%).
- Name badges are fully recyclable with no plastic covers.

- We invite delegates to give back their lanyards for donation/recycling after the conference.
- Lunch is provided on the first day of the conference, as a gesture of welcome while delegates find their way around.
 The packaging for the catered lunch is made from renewable resources and is fully recyclable or compostable.
- To reduce the amount of food waste, we are not providing lunch on subsequent days. The UK's food safety laws require that commercially prepared food only be served and kept at room temperature for a set amount of time, before it must be discarded. Leftover food cannot be donated.

We kindly ask delegates to:

- Consider bringing a refillable coffee cup for the coffee breaks.
- Consider bringing a reusable water bottle: these can be refilled at water fountains located on each floor of the conference venue.
- Think carefully about any conference-related printing and only print where absolutely necessary.
- Recycle materials where possible in the bins provided. Please be careful not to contaminate paper recycling with food waste.
- Refer to instructions from our catering team about the recycling and discarding of food waste.
- Use public transport where possible.



About the MSA 7th Annual Conference

Communities and Change

The Memory Studies Association 7th Annual Conference draws inspiration from New-castle's specific post-industrial material and social landscape. The city in the North East of England is part of a long industrial history linked to shipbuilding and coal mining, as well as a strong record of local activism and heritage driven by regional change and deindustrialisation. But the city's roots go deeper and spread wider, with its location on Hadrian's Wall – the northernmost frontier of the Roman Empire.

Newcastle is a city committed to social justice, from the Jarrow marchers who took the concerns of the unemployed to parliament to its status as a City of Sanctuary welcoming refugees. The changing communities that call Newcastle home impact the very shape of the city. The skyline of Newcastle upon Tyne and Gateshead, twin cities along the River Tyne, reflect these changes: walking through the city, one can easily recognise both the historic landmarks and the modern additions to the urban fabric. This reality is, quite literally, reflected in the imagery for this year's MSA Conference on Communities and Change.



"Communities and Change" also reflects the dynamism and diversity of Memory Studies as an expanding field. We live in a time where local and global communities and memories are shifting rapidly and being dramatically reconfigured. The MSA Newcastle Conference calls for a reflection on the ways in which individual and collective memories are constantly being shaped and reshaped, through communities and across the generations.

The MSA Newcastle Conference in July 2023 is the first to be held in the UK, taking its place alongside cities including Amsterdam, Copenhagen, Madrid, Charlottesville, Warsaw and Seoul.

Heritage of the North East of England

From Roman settlement to industrial hub

A Roman fort and bridge from the year 200 are the first recorded settlement of what is now Newcastle. Newcastle on the north and Gateshead on the south bank of the River Tyne have since changed into the largest metropolitan area in the north of England. Plenty of landmarks still remind us of the area's rich history as a major shipbuilding and manufacturing hub throughout the industrial revolution.



From left to right

- The Armstrong Building is the oldest building on the Newcastle University campus and opened in 1888, originally housing the College of Physical Science or Armstrong College.
- Grey's Monument on Grainger Street commemorates Charles Grey, 2nd Earl Grey, for his parliamentary reform in 1832.
- The Tyne Bridge^{*} links Newcastle upon Tyne and Gateshead and replaces the previous stone bridge in 1928. The location of the through arch bridge has been used to cross the River Tyne since the Romans built the first bridge in 122.

- The Baltic Centre for Contemporary Art^{*} is housed in a converted flour mill which operated from 1950 to 1984, situated in Gateshead on the south bank of the River Tyne.
- Newcastle Castle is built on the site of the fortress that gave the city of Newcastle upon Tyne its name. The prominent Castle Keep dates back to 1172.
- The War Memorial for Dunston at the junction of Ellison Road and King George Avenue in Gateshead is a Celtic Cross on an octagonal base, dedicated to locals who lost their lives in the First and Second World Wars.

The changing shape of Newcastle upon Tyne and Gateshead

From deindustrialisation to cultural hotspot

After the last coal mine closed in 1956, the area of Newcastle upon Tyne and Gateshead changed drastically. Redevelopment projects launched in the 1990s and at the turn of the century contributed to the now regional cultural hotspot. Modern additions to the urban fabric add to the heritage skyline of the twin cities.



From left to right

- St James' Park is the football stadium home to Newcastle United F.C. Its distinctive shape and asymmetrical stands stem from keeping the stadium in the original 1880 location amidst a changing city.
- The statue of Martin Luther King Jr.
 in the inner courtyard of the Armstrong
 Building on the Newcastle University
 campus was erected in 2017 to cele brate the 50th anniversary of his honor ary degree from Newcastle University.
 The inscription on the base reads:
 "There are three urban and indeed
 great problems that we face: racism,
 poverty, war."
- Since 2001, the Gateshead Millenium Bridge for pedestrians and cyclists has connected Gateshead's arts quarter with Newcastle's Quayside.


- SAGE Gateshead on the south side
 of the River Tyne is a concert venue
 and musical education centre. A glass
 and steel shell houses three sepa rate performance spaces with optimal
 acoustics for a wide variety of programming, specifically including the region's
 traditional music of Northumbria.
- At 46 meters, the Newcastle Airport
 Control Tower is one of the first tall
 structures people encounter when they
 arrive by plane.
- The Angel of the North overlooks a former colliery in Gateshead, standing at 20 metres tall with a wingspan of 54 metres. Artist Antony Gormley created the contemporary sculpture that has become a symbol of the North East.


^{*} While the Tyne river is tidal and flows towards the North Sea, kittiwakes travel in the opposite direction to nest under the Tyne Bridge and on the Baltic. They are the most inland breeding kittiwake colony in the world and can be seen (and heard!) when visiting these venues.

Directions to the Frederick Douglass Centre

- By Train (15 minute walk from Central Station): From Central Station cross the road onto Westgate Road. Turn left and walk up Westgate Road and then right onto Bath Lane. Cross over St James' Boulevard and continue on Bath Lane for 200m. The building is on the left hand side.
- By Metro (5 minute walk from St James Metro): From St James Metro Station cross over Gallowgate and walk up Heber Street (with the Sandman Hotel on your left). The building will be in front of you.
- By Bus (5 minute walk from Barrack Road): The nearest bus stop is Barrack Road-St James Park. Walk down Barrack Road in the direction of the City Centre. Turn right onto Heber Street and continue to Wellington Street. The building will be in front of you.
- **By Taxi:** Use the postcode NE4 5TG. Taxi's can drop off on Wellington Street, just outside The Frederick Douglass Centre.



Buildings and dedicated rooms

Parallel sessions will be held in the Frederick Douglass Centre, the Urban Sciences Building and the Newcastle University Business School, all at the Newcastle Helix site. There will be interns available on site to direct you between the three buildings. All buildings are fully accessible.

Building codes in the program are as follows:

- USB = Urban Sciences Building
- NUBS = Newcastle University Business School

A **nursing room** is available next to the main reception desk in the Frederick Douglass Centre.

There is also a dedicated **multipurpose quiet room** in the Newcastle University Business School: NUBS 1.14.

WiFi

Wireless Guest Service

Visitors who are not able to connect to eduroam can use the free cloud WiFi network WiFi Guest to access the Internet using their own computer. The service is provided free of charge, is simple to use and requires no configuration changes to the visitor's computer. The service is provided for visitors to University Open Days and Events and not recommended for permanent use. It does not provide access to University PCs or services.

The service is managed by The Cloud Networks Ltd and is the same free public WiFi service available in thousands of locations across the UK. You will need to create an account to use the service, unless you already have an account for The Cloud.

Creating an account

Here are the steps to get connected:

- From your device connect to the network WiFi Guest
- On The Cloud landing page locate the box Get online at Newcastle University and click Go
