Metrics for SCM - a literature overview

SCM people have for years supplied metrics data to the rest of the software organization because we sit on the repository, which is a literal gold mine of data waiting to be mined. Various parts of the organization have used these metrics to measure their efficiency and the effect of changes, to plan and schedule their resources, and to monitor their processes.

We believe it is about time SCM started using this gold mine of data themselves to pull out metrics that can provide the same benefits for the people, processes and tools that SCM is responsible for.

Since we did not want to reinvent the wheel, we started by looking around for previous work and inspiration - the result of which we report on in this first part.

Metrics and SCM

We have several times found ourselves in situations where we have had to convince other people of something. It could be to convince management that we need a new tool, or it could be to convince students that they should work in a different - and better - way on their projects. In the first case, the bean counters would often ask for the economic return - in the latter case, the students would usually say "yeah, right" and continue the same way they had always done (to be true, some students would ask "why").

In many cases it turned out that we had little more than "good reasoning" and "gut feeling" to argue our case. Gradually we realized that a couple of appropriate numbers in many cases could terminate endless discussions - or get attention from students or developers. So we started looking into metrics for SCM.

In general, metrics can be used for:

- funding change: first they buy-in, then we verify that savings are as promised
- planning: estimating and managing resources
- insurance: early indicators (trends) that we are (will be) going off track
- fine-tuning: comparison with benchmark values

There are many examples

of metrics around and much of the data for metrics is provided by the SCM team, because we sit on top of data and meta-data in our repository. In the beginning the "funding" part was most dominant for us, but gradually we discovered the advantages of the others. However, we were not interested in metrics in general, but only in metrics that could serve our specific interests as responsible for SCM tasks, tools and processes. Your situation as an SCM responsible might be different from ours, so some of the metrics we find valuable might not interest you - and the other way around.

Since our interest for SCM specific metrics started quite some time ago, most of our work was done prior to March 2007. We had wished for the special issue of the CM Journal to have happened two years earlier - that would have made our life easier. However, still find that it is worth reporting our experience to people that are in the same situation we were in back then. In this first part, we give an overview of existing literature related to SCM specific metrics.

CM Body of Knowledge

The first place one thinks to go for information - after Google - is to the Configuration Management Body of Knowledge [CMBoK]. Especially for a topic that sounds as exotic as metrics for SCM processes and tools.

The duality of the relation between SCM and metrics is reflected in their description of the two driving forces for the collection of data for metrics: information the project manager requires (which is what we consider to be the metrics SCM provides), and information the SCM team requires in order to monitor their own efforts (which is exactly what we are interested in). The CMBoK does not list many examples, but we would like to mention: cycle promotions as an indicator of workload, and average process time to monitor workflow effectiveness.

CM Books

In the context of books on configuration management, SCM metrics (if mentioned at all) are taken to mean that SCM through the status accounting activity provides the rest of the organization with numbers through regularly producing status accounting reports. So if one really wants to get any SCM specific metrics out of that, you have to go into the descriptions and dig out the parts (if any) of the status accounting reports that are targeted towards the SCM team itself.

The first explicit mentioning of metrics and SCM, that we have found, is Fletcher Buckley [Buckley, 1993], who in his book on configuration management has a section on metrics - sub-divided in configuration management metrics and project metrics. He primarily describes metrics as a bonus or by-product that project management can use in its work, but also hints at the fact that they can provide indicators of where improvements can be made to configuration management. To us, some of his examples of metrics seem to belong to the former category (lines of code, number of revisions to files); others are more in the spirit of our understanding (number of changes processed, number of open and closed problem reports).

More recent books on configuration management tend to include explicit mentioning of metrics, though there is still a bias towards SCM as a supplier of metrics and not so much as a consumer. Alexis Leon [Leon, 2005] mentions metrics in passing and list a number of examples, most of which look at as meant for others than the SCM team itself. However, there are some that we find interesting (average time to resolve a change request, percentage of change requests that conform, difference between estimated and actual value for activities).

Mario Moreira [Moreira, 2004] splits up his treatment of configuration management into three levels (organizational, application and project). For two of these levels he mentions how metrics can and should be used. At the organizational level there should be established measures of success for each of the SCM objectives (implicitly stating that these objectives should be made explicit), and he mentions the percentage of configuration items in the repository (which should ideally be 100%) as one such measure. At the application level he mentions examples that we tend to consider as provisions for others (percentage of files changed), but also some that we can relate to in our day-to-day business in the SCM team (build times and success rate). Moreira does not explicitly treat SCM metrics for the project level. It could be because he finds that they follow implicitly from the -sometimes rather detailed - SCM tasks he establishes for the project level.

A particular problem in trying to identify SCM specific metrics, as pointed out by Jessica Keyes [Keyes, 2004], is that many SCM activities are performed in interaction with (or even only performed by) other people. She believes that it is not the efficiency of the SCM activities, per se, that is important, but rather their result in contributing to the overall project objectives. We believe that she is right, but would still very much like to pursue our quest for metrics that are specific for SCM activities and tasks, and leave it to others to measure the compound effects.

CM Journal

The March issue of the CM Journal was dedicated to SCM and metrics. We have reviewed these papers [Appleton et al, 2007], [Wagner, 2007], [Kock, 2007], [Weatherall, 2007] and [Farah, 2007] in a previous paper [Bendix et al, 2007], so here we will only repeat that if you are interested in SCM and metrics, whether it is metrics for SCM or SCM providing metrics, then these papers are very inspiring sources of information.

In a previous paper [Farah, 2004], Joe Farah explains that metrics are very useful for tuning of processes and forecasting, and he gives some general advice on how to make metrics work. He gives an extensive list of his favourite SCM metrics, many of which are really interesting from the point of view of an SCM team. His examples are not all SCM metrics in our strict sense, but we would like to mention just a few of those we found interesting: SCM repository growth rate, revisions/branches per file, times to query history / retrieve files / create baselines and so on, and build preparation time. In his paper you will find

many more, plus an explanation of what he uses each metric for.

Whereas, Farah has many "technical" metrics, Henrik Jönsson [Jönsson, 2004] tends to have a more "administrative" bias in his approach to metrics for SCM. He focuses on the processes for handling change requests and shows both a number of specific metrics and how they can be visualized as graphs for easy understanding. Together with each metric it is explained how to use it, how it can be visualized and in some cases also how it can be combined with other metrics to give a more complete picture.

Other sources

Searching for SCM

specific metrics information on Google gives very little. There are many hits, but when you have filtered out hits that are about Supply Chain Management, you get very little.

A potential source for information could be white papers from tool vendors. It seems like there is no limitations to what they promise you, if you just buy their tool. In our opinion their figures have little credibility, also because there is no explicit mentioning of what exactly they compare with. Also many tool vendor white papers (none mentioned, none "forgotten") deal with return-on-investment, which is not really what we are looking for. However, we could still use bits and pieces from their calculations for inspiration for single metrics that could be valuable, like number of merged files, cost of browsing version history, and time to build.

Similarly, the work of Borracci [Borracci, 2005] is focused on a return-on-investment model and as such is of no direct interest to us. However, even though he has difficulties with his model because he cannot put financial value to some of his parameters, we can still use the parameters as metrics because we can actually measure them (like time-to-market). On the other hand, the study reported by Larsen and Roald [Larsen et al, 1998] seems more difficult to use for metrics as their parameters mostly measure compound effects, which makes it difficult to say what is due to improvement of SCM processes.

Summary

Navigating the

information highway wilderness, this is what we found. If you need to take a similar road, we can suggest you a map to start from. If someone knows of other sources of information, please let us/the community know.

As we stated in the beginning of this paper, your mileage may vary. You may be in an SCM context that is different from ours and have different needs. Therefore, we encourage interested people to read the referenced literature for more details on metrics and their relation to and use for SCM.

Even though literature is not abundant with examples of SCM metrics, we did find a few metrics that we were interested in trying out - and some more that served as good inspiration for coming up with others. More about this in part two, where we will describe a couple of case studies that led to some metrics for SCM processes that other people may/may not be able to use.
